

TOWN OF ALTONA
BY-LAW NO. 1783/2020

Being a by-law to revise and update the fees payable to the Town of Altona for municipal services rendered under the authority of The Municipal Act, The Noxious Weeds Act, and the By-laws of the Town of Altona.

WHEREAS the Council of the Town of Altona deems it advisable to include in one by-law the fees and charges payable to the Town for certain services rendered by officers and employees of the Town;

NOW THEREFORE the Council of the Town of Altona enacts as follows:


1. THAT the fees and charges payable to the Town of Altona for services rendered by officers and employees of the Town shall be as set out in the following schedules attached hereto;

2. THAT Council may from time to time, by resolution, amend each and every schedule attached to this by-law.
3. THAT the fees and charges set out in the schedules attached to this by-law shall take precedence over any other by-law.
4. THAT this By-law shall be known as the **Fees and Charges By-Law**.
5. THAT By-law No. 1747/2016 and subsequent amending By-law nos. 1759/2017 and 1764/2018 be repealed upon the final passing of this by-law.
