

TOWN OF ALTONA
BY-LAW NO. 1833/2025

Being a by-law to provide for the regulation of traffic and parking of vehicles in the Town of Altona and repeal of By-law No. 1784/2020 to be known as the "Traffic and Parking By-Law".

WHEREAS a municipality has the direction, control and management of municipal roads within its boundaries.

AND WHEREAS Section 90(1) of *The Highway Traffic Act* provides for a traffic authority to make rules or By-laws to regulate and control vehicular and other traffic and the parking thereof within its jurisdiction;

AND WHEREAS Section 90(2) of *The Highway Traffic Act* provides for the council of the municipality to impose penalties for a violation of any such rule by By-law;

AND WHEREAS Section 90(3) of *The Highway Traffic Act* provides for the council of a Town to make rules or By-laws applicable to any part of a provincial highway within the Town.

AND WHEREAS Section 236(1)(b)(ii) of *The Municipal Act* states,

236(1) Without limiting the generality of clause 232(1)(o) (enforcement of By-laws), and subject to subsection (3), a by-law passed under that clause may include provisions

(b) remedying contraventions of By-laws, including

(ii) subject to the regulations, providing for fines and penalties, including the imposition of a penalty for an offence that is in addition to a fine or imprisonment, so long as the penalty relates to a fee, rate, toll, charge or cost that is associated with the conduct that gives rise to the offence, or related to enforcing the By-law.

AND WHEREAS Section 236(3) of *The Municipal Act* states,

A contravention of a by-law

(a) designated under clause 3(2)(a) of *The Municipal By-law Enforcement Act*; or

(b) respecting the parking, standing or stopping of vehicles;

may not be enforced under *The Provincial Offenses Act*.

AND WHEREAS Section 3(2)(a) of *The Municipal By-law Enforcement Act* provides that a municipality may require administration penalties to be paid if the municipality designates the by-law contraventions that may be dealt with by a penalty notice.

AND WHEREAS Council of the Town of Altona has passed the by-law to provide for an administrative penalty scheme for parking and general by-law enforcement, By-Law 1760/2018, referred to as the “MBEA Enabling By-Law”;

AND WHEREAS the Council of the Town of Altona, deems it necessary and in the best interests of the municipality to restrict the parking of trucks and trailers on streets in the Town of Altona;

AND WHEREAS it is deemed necessary and expedient to pass a By-law to regulate and control vehicular and other traffic and the parking thereof within the Town of Altona;

THEREFORE BE IT AND IT IS ENACTED AS FOLLOWS:

Article 1 - Definitions

“Chief of Police” shall mean the Altona Chief of Police or any and all officers of the Altona Police Service which may be empowered to act on behalf of the Chief.

“By-Law Enforcement Officer” shall mean a person appointed or designated under *The Municipal Act* to enforce the By-laws of the Town of Altona and includes a designated employee or officer under *The Planning Act*.

“Designated parking space” means a space designated by signs or pavement markings as being for the sole use of motor vehicles displaying a permit and that is located:

on a highway;

in a public parking lot or facility; or

in a private parking lot or facility to which the public has access.

“Diagonal Parking” or “Parking in a Diagonal Manner” means that to park a vehicle so as to form, as near as possible, a forty-five (45) degree angle with the curb of the street.

“Double Parked” means to park a vehicle adjacent to a vehicle that is parallel parked.

“Loiter” means to remain in an area for no obvious reason.

“Motor vehicle” means a motor vehicle as defined in *The Highway Traffic Act*.

“Owner” means the registered owner of a property or their designate.

“Park” means when prohibited, means to stand a vehicle whether occupied or not, except:

when it is caused to stand temporarily for the purpose of, and while actually engaged in, loading or unloading; or
in obedience to a peace officer or a traffic control device,
and “parking” has a corresponding meaning;

“Parallel Parking” or “Parking in a Parallel manner” means to park a vehicle headed in the direction of traffic with the curbside wheels not more than forty-six (46cm) centimeters (eighteen inches) from the curb or if there is no curb, it shall be off the travelled portion of the streets, and in such a way so as not to block the street for other vehicular traffic.

“Permit” means a valid physically disabled person’s parking permit issued under Section 124.3 of *The Highway Traffic Act*.

“Persons” shall mean any individual, firm, company, association, society, corporation, or group.

“Public Works Department” shall mean all works and operating department staff of the Town of Altona which perform work upon a public street or lane within the Town.

“Sidewalk” means a footpath, whether or not paved or improved, that is intended primarily for the use of pedestrians and that either:
forms part of that portion of a highway that lies between the curb line or, if there is none, the lateral boundary line, of the roadway; and
the adjacent property lines; or
the straight production of the adjacent property lines to the curb line or if there is none, to the lateral boundary line, of an intersecting highway; or

although not part of a highway, is a publicly maintained right-of-way, set aside for pedestrian traffic only and for the purpose of giving access to property adjacent thereto.

“Special event” shall mean a parade, procession, block party, or such other event held on a public street, lane or thoroughfare which will require closure to public traffic.

“Street” shall mean a municipal road for public use and includes a road allowance (including the shoulder), street, lane, thoroughfare, walkway, bridge, and underpass but does not include a departmental road as defined in *The Highways and Transportation Act*.

“Vehicle” means a device, in, upon, or by which a person or thing is or may be transported or drawn upon a highway but does not include:

a device designed to be moved by human power or used exclusively upon stationary rails or tracks; and
a motorized mobility aid.

Article 2 - Temporary Street Barricades & Closures

Section 2.1 Persons wishing to have a special event on any street or streets in the Town of Altona, shall make application with the Altona Police Service, Chief of Police, who shall review the application and may approve or reject the application (with conditions) and so advise the applicant within five (5) business days of date of filing thereof. The application (see Schedule “A”) shall include the nature of the parade, procession, or special event, the route intended to be taken, the date and length, and the person or persons responsible for the event. The Chief of Police is hereby empowered to barricade or cause to be barricaded or erect a sign or remove a sign on any street or portion thereof deemed necessary for this event. If the event requires public

awareness through the press or other means this shall be done at the expense of the applicant.

Section 2.2 Parking during special events, (such as auction sales, Sunflower Festival, etc.) may be allowed to contravene this by-law if appropriate applications are made and approved by the Altona Police Service at least five (5) business days prior to any such scheduled event.

Section 2.3 No person shall park on a public street or lane at such time or manner to obstruct the performance of scheduled or emergency maintenance work on the public street or lane. The Town of Altona Public Works Department may post, close or detour any such streets it deems necessary in order to perform maintenance and/or construction work as necessary from time to time.

Article 3 - Traffic & Parking Restrictions

Section 3.1 No person shall park a vehicle where a sign or painted curb, placed and/or authorized by the Town of Altona, prohibits parking, and where a sign has been erected prohibiting the parking of vehicles during certain hours or days.

Section 3.2 No person shall park a vehicle on a street in such a manner that it obstructs the entrance to a lane or to a driveway or an approach leading into a private premise or public pathway.

Section 3.3 No person shall stand or park a vehicle within three (3) meters of an intersection.

Section 3.4 No person shall park a vehicle within three (3) meters from the point of the curb or edge of the roadway immediately opposite of a fire hydrant.

Section 3.5 No person shall park a vehicle within one hundred (100) meters of the scene of a fire or emergency except firefighting equipment or other emergency vehicles required in the firefighting operations.

Section 3.6 No person shall park a truck with a gross vehicle weight rating of 6,804 kg (15,000 lbs) or more, nor semi-trailers of any type, on any street within the Town of Altona, except when a truck or trailer is parked on a street during the course of loading and unloading. Such loading and unloading shall be done as quickly as possible and in such a way so as not to block the street for other vehicular traffic.

Section 3.7 No person shall park a vehicle in a single location on a street for forty-eight (48) consecutive hours or more, within the Town of Altona.

Section 3.8 No person shall park a utility trailer, recreational trailer, motorhome, or conversion van or bus converted into a motorhome, either connected or disconnected to any other vehicle, on any street within the Town of Altona, except when it is parked on a street during the course of loading and unloading. Such loading and unloading shall be done as quickly as possible and in such a way so as not to block the street for other vehicular traffic.

Section 3.9 No person shall park a semi-trailer unit, or part thereof (either tractor or trailer, either connected or separately), or other heavy vehicle on any Town owned parking lots.

Section 3.10 No person shall park a vehicle upon or over a sidewalk or in front of a public pathway which will obstruct the use of the sidewalk/pathway by pedestrians.

Section 3.11 No person shall stop, stand or park a motor vehicle in a designated parking space for physically disabled persons, or in a

manner that makes a designated parking space inaccessible, unless the vehicle displays a permit in accordance with *The Highway Traffic Act* and the regulations under that Act.

Section 3.12 No person shall drive any vehicle of whatever kind across any highway except at intersections and no complete or “U” turns shall be made on any thoroughfare.

Section 3.13 No person shall drive any vehicle upon or across any sidewalk, except for the purpose of crossing at an intersection or to enter upon a premises.

Section 3.14 No person shall park a vehicle, except an emergency vehicle, on any roadway other than parallel with the curb, headed in the direction of vehicular traffic movement in the adjacent traffic lane with the curb-side wheels of the vehicle within 45 centimeters of the curb.

Section 3.15 No person shall park a vehicle within 2 meters of a crosswalk.

Article 4 - Parking During Snow Removal

Section 4.1 Persons shall remove parked vehicles and refrain from parking on public streets and lanes during and after snowfall events which require the removal of accumulated snow. Persons may resume parking on streets after snow removal operations have been completed.

Section 4.2 No person shall deposit snow from private properties onto public roads, streets and lanes. Persons found depositing snow on public roads, streets and lanes will be charged the cost to remove such snow.

Article 5 - Funeral Processions / Emergency Vehicles

Section 5.1 All vehicles in a funeral procession shall be indicated as such by flashing hazard lights and, upon approaching a traffic signal, stop signal, stop sign, or other traffic control device, shall slow down as may be necessary for safety, but shall have the right of way over all other vehicles except emergency vehicles and may proceed cautiously past the signal or sign.

Section 5.2 Upon the approach of an ambulance, police, or fire department vehicle, giving a clearly audible signal by bell, siren, or horn, the driver of every other vehicle shall immediately drive into a position as near as possible to, and parallel to the right-hand edge or curb.

Article 6 - Traffic & Parking Regulations

Section 6.1 Traffic control or direction signs as shown in Schedule "B" attached to this By-law shall be deemed to be in force at the time of the passing hereof and said Schedule "B" or any amendments thereto shall form part of this By-law.

Section 6.2 Parallel parking of vehicles is required on all streets where parking is permitted in the Town of Altona, except locations identified in Schedule "B" to this By-law where diagonal or right-angle parking is required.

Section 6.3 Traffic control and parking regulations may be posted as per Schedule "B" to this By-law and can henceforth be amended from time to time by Resolution of Council.

Section 6.4 Wherever a "Stop" sign has been duly erected at an intersection or level railway crossing, the driver shall bring that vehicle to a complete stop before traversing the intersection or railroad crossing, and shall not proceed until it is safe to do so.

Section 6.5 Wherever a “YIELD” sign has been erected, the driver of every vehicle shall yield the right-of-way to the driver of any vehicle approaching the intersection from any direction other than that from which the driver first named herein is proceeding.

Section 6.6 Any sign, marker, poster, notice or device heretofore or hereafter erected or installed purporting to direct, control or otherwise regulate the use of any highway in the Town of Altona shall prima facie raise the presumption that the sign, poster, notice or device was duly erected and maintained by the Town of Altona and shall be observed and the directions or instructions thereon complied with by any and all drivers or operators of vehicles.

Article 7 - Loading Restrictions/Regulations

Section 7.1 No person shall park in a street, except for the purpose of loading and unloading. Such loading and unloading shall be done as quickly as possible and in such a way so as not to block the street for other vehicular traffic. Provision for one vehicle to pass shall be made at all times.

Section 7.2 No vehicle shall stand backed up to the curb except when actually loading or unloading. In no event shall a vehicle be so parked as to interfere with the passage of other vehicles.

Article 8 - Street Safety

Section 8.1 No person shall deposit leaves, refuse, earth or other materials from private properties onto public roads, streets, lanes, or ditches. Persons found depositing leaves, refuse, earth or other materials onto public roads, streets, lanes, or ditches may be charged the cost to remove such leaves, refuse, earth or other materials.

Section 8.2 No person other than a utility shall place or leave on or across any part of a Town street, boulevard or sidewalk, an

unattended wire, cord or cable, that is capable of transmitting electrical energy from public or private property to or across a Town street.

Article 9 - Engine Retarder Braking System

Section 9.1 No person shall use an engine retarder braking system on any motor vehicle being operated within the limits of the Town of Altona.

Article 10 - Enforcement

Section 10.1 The Altona Police Service is hereby authorized to enforce the following traffic regulations on private and public parking lots upon request by the Owner and all Municipal Parking Lots where the required signage is in place, namely:

- Actively Charging Electric Vehicles Only
- Physically Handicapped Parking Only
- No Parking, Fire Lane
- Emergency Vehicles Only
- No Parking, Loading Area
- No Parking, Entrance Only or Exit Only
- No Loitering, Littering, or Excessive Noise
- No Parking

Section 10.2 A Constable of the Altona Police Service or other person authorized by the Chief of Police, or the By-law Enforcement Officer may order a vehicle be towed away when it:

- a. occupies or partially occupies a Fire Lane;
- b. occupies a railway crossing;
- c. is parked within 3 meters of a Fire Hydrant;
- d. is double parked;
- e. is parked in an area designated as "No Parking";
- f. is parked so as to impede the normal flow of traffic;

- g. is parked in such a manner as to create a hazard to private and/or public property; or
- h. is parked in such a manner so as to restrict access or egress to or from private or public property.

Section 10.3 Whenever an officer removes or has a vehicle removed from a Street or an off-street parking area, as authorized in the above noted section of this By-law, such officer shall take all reasonable steps to notify the owner that such motor vehicle has been removed and impounded, together with reasons for its removal or impoundment and of the place where it is being detained or stored.

Section 10.4 No person shall recover any vehicle removed and impounded in accordance with this By-law except as provided by for herein:

- a. a release form (see Schedule "C") has been provided to such person by the Chief of Police of the Town of Altona;
- b. evidence of ownership has been provided by the person requesting release of the vehicle, or the right to possession of such vehicle has been provided by the person requesting release of such vehicle; and
- c. any person requesting the release of such vehicle shall:
 - i. sign a receipt for its return;
 - ii. pay for the cost of removal of such vehicle; and
 - iii. pay for the cost of storage accrued for such vehicle.

Section 10.5 It shall be the duty of the Chief of Police of the Town of Altona to keep a record of each vehicle removed in accordance with the provisions of this By-law.

Section 10.6 Any Constable of the Altona Police Services or other person authorized by the Chief of Police or the By-law Enforcement Officer of the Town of Altona may issue a penalty notice to any person who has allegedly contravened any of the provisions of this By-law.

Section 10.7 A penalty notice must be in a form set out in Schedule "B" to the MBEA Enabling By-Law No. 1765/2018 and shall be delivered to the affected person in accordance with that by-law. The penalty notice must be issued to a named person unless it is issued for a by-law contravention respecting the parking of a vehicle, in which case the notice must set out the registered owner, as determined by the vehicle's license plate or, if none, the vehicle identification number or serial number in some cases.

Section 10.8 In the event that a violation under this By-law, other than a violation respecting the parking of vehicles, is also a violation under *The Highway Traffic Act*, the Constable may issue a penalty notice under the provisions of this By-law or a ticket under the Provincial Offenses Act, at their discretion.

Article 11 - Penalties

Section 11.1 Any person guilty of a breach of this By-law shall pay the administrative penalty outlined in Schedule "A" of the MBEA Enabling By-law No. 1760/2018 or request a review by a screening officer in accordance with Part II of said By-Law.

Section 11.2 That the amount of the administrative penalties set out in Schedule "A" to the MBEA Enabling By-law 1760/2018 may be amended from time to time by Resolution of Council.

Article 12 - Other

Section 12.1 By-law No. 1784/2020 is herewith repealed.

Section 12.2 If any provision of this By-law is determined to be unenforceable or invalid, the remaining provisions of this By-law will continue to be valid and enforceable.

Section 12.3 This By-law shall come into force and effect immediately upon the passing thereof.

Section 12.4 This By-law shall be deemed to legislate only with respect to matter, things, occurrences or situations which may lie, or arise within the legislative jurisdiction of the Town of Altona and nothing contained herein shall be deemed to enact anything beyond the authority and the jurisdiction of the Town of Altona.

Section 12.5 This By-law may be referred to as the "Traffic and Parking By-Law".
